WHEREAS, THE MATTER BROUGHT BEFORE THE Court was the setting of a tax rate as required by Article 26.05, Texas Tax Code; and

WHEREAS, after notice and hearing, the following motion was offered by Commissioner Braziel and seconded by Commissioner Call: "I move that the property tax rate be set by the adoption of a tax rate of 0.6171.

The Tax Rate for the **Year 2019** is computed as follows:

0.5962 **Total Maintenance & Operating** 0.0209 **Debt Service** 

0.6171 **Total All Funds** 

The above rates are per \$100 of assessed valuation.
